CASTILE RESOURCES DRILLING PROGRAM UPDATE

Castile Resources Limited (ASX:CST) ("Castile" or "the Company") advises that it now received the results from the last hole of its 2020 drill program with the assays from hole 20CRD004 and the daughter hole 20CRD004-1 received.

Holes 20CRD004 and 20CRD004-1 (a daughter hole navi-cut from the parent hole) were designed to test plunge extents of the interpreted Ganymede mineralisation discovered in hole WGR1D043-2 which had been drilled by the previous owners. These two holes were 50m and 100m away from the mineralisation in this hole.

The Ganymede target was the second of the wildcat exploration type targets tested in the shortened field season of 2020 with the structural target at Western zone (See ASX:CST 16 December 2020) being the other.

Anomalous copper results were received in two zones (see Table 1) in both 20CRD004 and 20CRD004-1 suggesting drilling was peripheral to mineralisation.

The Managing Director of Castile Resources, Mark Hepburn, commented "Whilst the exploration targets at Ganymede and Jupiter West did not return high grade intercepts, they have returned significant anomalism suggesting that there remains potential to extend the known Rover 1 ore system. Castile will continue to proactively work through the numerous conceptual opportunities contained within the Castile tenements in parallel with advancing development at Rover 1.

The extensional holes drilled into the main Rover 1 ore system during the shortened season did return outstanding intercepts including 30.4m @ 35.6g/t Au and 1.46% Cu in 20CCRD001 (See ASX:CST 20th October 2020) and 12.3m @ 4.5g/t Au and 1.49% Cu, g/t in 20CRD002 (See ASX:CST 2nd November 2020) These have greatly increased our confidence levels in Rover 1 and we will continue to focus on progressing the Pre-Feasibility Study."




Figure 1: Long projection of Jupiter Deeps and Ganymede zones at Rover 1 showing pierce points of 20CRD004 and 20CRD004-1 with historic drillhole intersections and Au Gram x Meter contouring

The sample of between 0.5kg to 3kg is whole crushed then pulverised to produce a 40g charge for fire assay with AAS finish for Au and a further sample for mixed acid digest with an ICP-MS finish for Ag, As, Bi, Co, Cu, Pb and Zn. To ensure representivity of samples, field blanks and certified reference material is inserted in a nominal ratio of 1:20 samples. Sample recovery is recorded on retrieval of the core tube, measuring recovered core against drill string advance. No apparent relationship has been observed between sample recovery and grade. No has sample bias due to preferential loss or gain of fine or coarse material been noted.
