

SIGNIFICANT COPPER GRADES ACCOMPANY GOLD INTERCEPTS FROM ROVER 1

Castile Resources Limited (ASX:CST) ("Castile" or "the Company") is pleased to announce that it has received the copper, bismuth, cobalt and silver assays from the first hole in its inaugural drilling program at the Rover 1 Prospect. These co-products assays compliment the high-grade gold only results from this drill hole previously announced to the market. (See ASX announcement Wednesday 14 October 2020. "Stunning Gold Intercepts from Rover 1 Amended")

Significant intercepts with co-products added now include:

- 30.4m @ 35.6g/t Au with 1.46% Cu, 0.18% Bi, 0.09% Co and 3.31g/t Ag from 506.5m
 in downhole diamond hole 20CRD001 including:
 - 6.5m @ 7.48g/t Au with 2.07% Cu, 0.38% Bi, 0.12% Co and 4.19g/t Ag from 506.5m downhole
 - 13.2m @ 76.27g/t Au with 1.16% Cu, 0.15% Bi, 0.1% Co and 4.43g/t Ag from 518.95m downhole

The sub-parallel zone higher up in the hole returned an intercept of:

• 3.1m @ 12.34 g/t Au with 3.05% Cu, 0.12% Bi, 0.13% Co and 2.32g/t Ag from 492m downhole.

Managing Director Mark Hepburn commented:

"Rover 1 is an iron oxide copper-gold (IOCG) polymetallic deposit typical of the Tennant Creek style containing high grade gold with coincident copper, bismuth, cobalt and silver. The copper and other co-products in the Rover 1 deposit have the potential to be commercially very significant for Castile when added to the gold endowment. Our current focus is clearly our ongoing drilling programs, with significant work progressing in parallel on how best to unlock maximum value from the tremendous "free kick" that the co-products within Rover 1 provide. Castile looks forward to updating the market with the progress on further drilling and these studies as they come to hand".




Figure 1: Cross section showing postion of drillhole 20CRD001 with respect to surrounding drillholes. Refer to Figure 2 for detail.




Figure : Close up of Figure 1 showing historic gold intersections in surrounding drillholes






Figure 3: Rover Mineral Field Tenure Map

Competent Person's Statement

The exploration results contained in this report are based on, and fairly and accurately represent the information and supporting documentation prepared by Mark Savage. Mr Savage is a full time employee of Castile, and a Member of The Australasian Institute of Mining and Metallurgy. All data used in the following sections at Rover 1 has been gathered from diamond core. Multiple sizes have been used historically; HQ, NQ and BQ. Samples are selected to lie on geological boundaries, with intervals selected of lengths between 0.1 to 1.1m. Samples are halved using an automatic core saw then individual samples collected in prenumbered calico sample bags. The sample of between 0.5kg to 3kg is whole crushed then pulverised to produce a 40g charge for fire assay with AAS finish for Au and a further sample for mixed acid digest with an ICP-MS finish for Ag, As, Bi, Co, Cu, Pb and Zn. To ensure representivity of samples, field blanks and certified reference material is inserted in a nominal ratio of 1:20 samples. Sample recovery is recorded on retrieval of the core tube, measuring recovered core against drill string advance. No apparent relationship has been observed between sample recovery and grade. No has sample bias due to preferential loss or gain of fine or coarse material been noted.

The crushed sample is then pulverised in a Labtech LM5 Ring Mill such that 90% passes 75um. 200g is split and placed in a packet for analytical work. For every 20th sample, an approximately 25g sample is wet screened to check grind effectiveness. From the analysis sample, 40g is taken for fire assay, while a 0.2g potion is taken for acid digestion. These samples are extracted from the packet with a spatula and weighed out. QA/QC is ensured during sampling via the use of sample ledgers, blanks, standards and repeats. QA/QC is ensured during the assays process via the use of blanks, standards and repeats at a NATA / ISO accredited laboratory. The sample sizes are considered appropriate to the grainsize of the material being sampled. The un-sampled half of diamond core is retained for check sampling if required.

Samples returning assay values in excess of 100g/t Au were repeated using the screen-fire method. Silver, bismuth, cobalt, copper, lead and zinc samples are digested using a 4 acid digest. The subsequent solution is analysed by inductively coupled plasma - atomic emission spectroscopy or by atomic absorption spectrometry. No significant QA/QC issues have arisen in recent drilling results. These assay methodologies are appropriate for the style of mineral deposit under consideration.

Copper manifests as of chalcopyrite, associated with breccia fill within magnetite-quartz ironstones and Jasper/BIF that often form an alteration transition to a chlorite alteration envelope.
